TERMS AND CONDITIONS FOR USAGE OF SCHOOL PREMISES

Hirers shall ensure that they have a policy of insurance to cover all liabilities up to at least £2,000,000 (Two million pounds) and a copy of the current insurance certificate must accompany the booking form.

- Invoices are produced on receipt of application and full payment is expected immediately for single bookings, half termly and termly bookings. Failure to comply will mean the booking is cancelled; this condition could result in future bookings being cancelled and may also incur a financial penalty. Hirers requesting a single booking will be required to pay the full amount in advance.
- 2. The hirers will leave the premises in a clean condition and in good order and vacated not later than the time booked. The hirer shall replace any furniture/equipment they may have moved. The school reserves the right to charge for any additional cleaning that is required as a result of the premises not being left in a clean condition.
- 3. The hirer shall pay to the school the cost of repair or replacement resulting from any loss of damage arising from the hiring however caused or of whatever nature to the school premises and all equipment or property, thereon (whether provided by the school or any other body or person). Hirers shall notify the school Bursar as soon as possible of any damage.
- 4. Any cancellation must be submitted in writing. <u>No refund will be made for notification received within</u> <u>5 working days of the booked date.</u>
- 5. A hirer must not sub-let to another party.
- 6. Food, drink, and smoking are not permitted in any of the school buildings. Alcohol should not be consumed within the school grounds or buildings (except private functions by arrangement)
- 7. Appropriate footwear must be worn in the hall. Studded boots, spikes and blades, stiletto heels are not permitted.
- 8. All hirers are responsible for ensuring that users have agreed evacuation procedures in place and have provided the necessary first aid equipment, and have a mobile phone for emergencies.
- 9. Hirers shall ensure that dogs are not permitted within the school grounds or buildings.

The school will give notice at the commencement of the relevant academic term of any dates during that term which will not be available to the Hirer because of school commitments.
